### **Criminal Defence Role**

Having worked in psychology for the past 18 years, Dr Moore has over 10 years' experience of providing medicolegal assessments for criminal defendants, including clients with suspected intellectual difficulties, learning disabilities, autism, psychological disorders, stroke, dementia and brain injuries. He has repeated experience of delivering expert evidence in court, assisting decisions on causation, capacity and disposal options. He focusses in delivering criminal defence services within the South West of England.

### **Other Positions**

Dr Moore also has 10 years' experience of conducting medicolegal assessments in civil cases, mainly in the areas of personal injury and catastrophic injury involving brain injury and psychological trauma. He also so provides psychological trauma treatment (EMDR), neuropsychological rehabilitation and CBT locally. He lectures on the topics of brain injury and neuropsychology at the South West's two leading Universities. He provides Neuropsychology consultancy to a private care company and he has also been appointed by the Office for the Public Guardian as a Court of Protection 'Special Medical Visitor'.

### **Recent Positions**

Dr Moore has worked as a Consultant Neuropsychologist on a multinational controlled trial of a treatment for cognitive impairment. He has also worked as a Consultant Clinical Psychologist and Clinical Lead for the National Autistic Society and for the NHS Community and inpatient Neuropsychology Neuro-Rehabilitation service in Exeter. His final NHS work was heading North Devon's NHS stroke and acquired brain injury psychology service.

## **Training Background**

Dr Moore completed his first degree in Psychology and Criminology at the University of Keele and the University of Texas in 2001. In 2004 he started working in the NHS and he moved from working in learning disabilities, to focussing upon training in CBT in Primary Care Mental Health at the University of Plymouth. In 2006 he began his Professional Doctorate in Clinical Psychology at the University of Exeter, specialising in forensic and neuropsychological clinical work. He has also completed the post-doctoral diploma in Clinical Neuropsychology at the University of Bristol. Dr Moore is guest lecturer at the Clinical Psychology doctorate at both Plymouth University and Exeter University on the topics of brain injury and clinical neuropsychology.
