SUMMARY

I am a Chartered Consultant Clinical, Forensic and Neuro-Psychologist. Currently.

I hold clinical appointments in the Forensic Service of South West London and St. George's NHS Foundation Trust and running a long established private clinic practice. I also hold the posts of Honorary Lecturer and Researcher in the Psychology Department at Kings College London and the Institute of Psychiatry in London, where I teach and supervise trainee Psychologists.

Previously, I have been appointed as Head of Psychology and Psychological Therapies for The Dene & Pelham Woods hospitals, which are part of the Partnerships in Care group. These hospitals provide secure unit care for male and female Mentally Disordered Offenders. Previously I worked at Oakview Hospital for Adolescents with behavioural and mental health difficulties. I was previously employed as Head of Psychological and Talking Therapies in Forensic Services of the South London and Maudsley NHS Foundation Trust.

I have over 20 years experience assessing and treating mentally disordered offenders as well as commenting upon psychological issues pertinent to offending for Court purposes.

I have many years of experience in assessing and treating sex offenders with and without formal mental disorder. In addition to this, I have several years experience in the assessment and treatment of individuals who have suffered extreme trauma and have conducted assessment in matters of criminal injuries compensation and asylum. I have vast experience preparing reports for a number of different Courts, both civil & criminal, including experience offering oral testimony and experience of offering opinion in Murder trials, family court and immigration tribunals.

I conduct court assessments around 120 times per year and have appeared to give evidence many times, having been instructed by both the defense and prosecution. I have conducted assessments of inmates on death row in the Caribbean in cases of appeal before the Privy Council.

I have a B.Sc.
