Most often this included prescription of rapid tranquilization whilst ensuring patient's physical health was closely monitored. I worked alongside the MDT in making decisions regarding patients who had been in seclusion or long term segregation. I wrote reports for, and gave evidence at tribunals. I also assessed patients for admission to Broadmoor Hospital and provided comprehensive reports to the admission panel. I was also involved in a quality improvement project aimed at improving quality of care of patients who were in long term segregation.

This was a six month placement on a low secure ward where I was responsible for day to day care of the patients, including physical and mental health. I enjoyed the challenge of having extra responsibilities in absence of my

consultant, which involved chairing ward rounds, CPA and 117 meetings, and taking appropriate decisions whilst bearing in mind patient's views and team opinion. I also had the opportunity to write reports for, and give evidence at the managers' hearing and First Tier Tribunal. I gained experience in writing psychiatric reports on instructions from Courts and Solicitors. I wrote reports on matters such as fitness to plead and stand trial, presence of mental disorder and personality disorder, not guilty by reasons of insanity and advice on case disposal.

As a part of this placement I spent one day a week at the local prison, HMP Lewes. This involved conducting a ward round for inmates admitted on the health care wing. These were inmates who were admitted for assessment and treatment of mental health condition. My role was to identify their treatment needs and formulate appropriate care plans such as- treatment with medication, referral to psychology and/ or arranging transfer to secure hospitals.

I also conducted an outpatient clinic which involved carrying out new assessments and follow ups.

I also gained experience in community forensic psychiatry, which involved follow up of patients discharged from the secure inpatient settings and assessing new referrals received from general community mental health teams and probation services for risk assessment or case management.

This placement was on a male medium secure rehabilitation ward. I worked alongside the clinical team for a smooth and safe transition of our patients into the community.

My role involved identifying outstanding treatment requirements and liaising with outside agencies involved in patients' care. I conducted ward rounds and chaired CPA meetings in absence on my supervisor. I completed HCR 20 risk assessments for our patients. I also gave written and oral evidence at the Mental Health Tribunals. I assessed patients referred by the community teams for risk assessments. I also worked out of hours on a 1:6 on call rota, which included assessment of acutely unwell patients detained under Section 136.

I was placed on an acute high secure admissions ward where I worked alongside the clinical team in assessment and management of newly admitted acutely unwell patients. This involved managing acute crisis situation such managing severely disturbed patients. Most of these patients required management in seclusion and prescription of rapid tranquilization. I made sure my patients were physically well and at times this involved constant liaison with the hospital GP and practice nurses. I carried out pre-admission assessments including writing comprehensive reports and risk assessments. I worked alongside my colleagues in identifying treatment needs of the patients and lead the clinical team on various patients' related matters in absence of my supervisor. I made application for SOAD (Second opinion for treatment) for patients who would refuse treatment and on rare occasions used section 62 in cases of emergency. I gave evidence at Crown Court with recommendations for 37/41 for one of our patients who was convicted of a sexual offence. I gave written and oral evidence at the tribunal. I delivered teaching for medical students and fellow colleagues. I also organised a seminar on medical education in psychiatry- recruitment and retention whilst in this placement.

RESEARCH

I pursued research as my special interest during my higher training. I spent one day a week on a research project with the College Centre for Quality Improvement (CCQI), Royal College of Psychiatrists under the supervision of Professor Mike Crawford. The project was called "Controlled evaluation of a quality network for low secure mental health services". This was a two-armed, parallel group, pragmatic, randomised controlled trial of early or late participation in low secure quality network.

Services that were randomised to late participation in the quality network had an opportunity to join the network 12 months after randomisation. I joined this project in 2012 during my higher training rotation. In the beginning of the project I helped with the finalisation of the research questionnaires for data collection.

In the subsequent period my role had been in collecting data from low secure units in various parts of the country. This had involved collecting information from patients, managers, front line clinical staff and completing an environmental checklist. The final data is being analysed. The study has so far resulted in two publications.
