### **Employment History**

I work independently offering services to children, adults and families with a range of emotional and mental health difficulties. Such difficulties range in levels of severity, but often do not meet NHS criteria, even though such difficulties impact significantly on quality of life, work, school, and relationships. I also act as an expert witness to the court for both criminal and civil cases, and conduct medico-legal assessments. Such assessments are largely around personal injury, clinical negligence and family court proceedings. I also offer intervention and therapeutic work where indicated for such cases.

I worked part time for a private company who specialised in working with looked after children in residential settings. I worked one to one with young people across a broad spectrum of difficulties including depression, anxiety, stress and trauma. I also consulted with staff teams regarding the care of the children, and offered training around the mental health issues and associated behaviour that can affect young people in care. I worked collaboratively with the local authority, to help address the on going social, emotional and mental health issues of looked after children and their families. Alongside this work I also ran an adult clinic, offering therapy for mild to moderate mental health difficulties. I also conducted medico-legal assessments for both criminal and civil cases.

I held a split post, working in a secure mental health setting for young people largely deemed a risk to themselves, as well as working with young offenders under the age of 21 who were held in a young offenders institute.
